A copy of the appeal must be served on the Director of the Ohio Environmental Protection Agency and the Environmental Law Division of the Office of the Attorney General within three (3) days of filing with the Board. 

The above named entity is hereby granted a permit to install for the above described source(s) pursuant to Chapter 3745-31 of the Ohio Administrative Code. Issuance of this permit does not constitute expressed or implied approval or agreement that, if constructed or modified in accordance with the plans included in the application, the above described source(s) of environmental pollutants will operate in compliance with applicable State and Federal laws and regulations, and does not constitute expressed or implied assurance that if constructed or modified in accordance with those plans and specifications, the above described source(s) of pollutants will be granted the necessary permits to operate (air) or NPDES permits as applicable.

This permit is granted subject to the conditions attached hereto.

Substantial construction for installation must take place within eighteen months of the effective date of this permit. This deadline may be extended by up to twelve months, if application is made to the Director no less than sixty days before the expiration of this permit and the party shows good cause for any such extension.

The Director of the Ohio Environmental Protection Agency, or his authorized representatives, may enter upon the premises of the above named applicant during construction and operation at any reasonable time for the purpose of making inspections, conducting tests, examining records or reports pertaining to the construction, modification or installation of the above described source of environmental pollutants.

If the construction of the proposed source has already begun or has been completed prior to the date the Director of the Ohio Environmental Protection Agency approves the permit application and plans, the approval does not constitute expressed or implied assurance that the proposed facility has been constructed in accordance with the approved plans. The action of beginning and/or completing construction prior to obtaining the Director's approval constitutes a violation of OAC Rule 3745-31-02. Furthermore, issuance of the Permit to Install does not constitute an assurance that the proposed source will operate in compliance with all Ohio laws and regulations. Approval of the plans in any case is not to be construed as an approval of the facility as constructed and/or completed. Moreover, issuance of the Permit to Install is not to be construed as a waiver of any rights that the Ohio Environmental Protection Agency (or other persons) may have against the applicant for starting construction prior to the effective date of the permit. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed facilities prove to be inadequate or cannot meet applicable standards.

The specified permit fee must be remitted within 15 days of the effective date of this permit to install.

This permit shall apply only to the source(s) shown on the application approved by the Ohio Environmental Protection Agency.

The appropriate District Office of the Ohio EPA or Local Air Pollution Control Agency shall be notified, in writing as to (a) the construction starting date (b) the construction completion date and (c) the date the facilities were placed into operation.

This Permit to Install is applicable only to the installation and/or modification of the following air contaminant sources, wastewater disposal systems and solid waste disposal facilities:

As specified in OAC 3745-31-05, all new sources must, at a minimum, employ Best Available Technology. The following terms and conditions fulfill these requirements and any applicable federal regulations.

Allowable mass emission limitation(s) and/or control requirements:

The mass emissions from this source shall not exceed the following:

6.0 tons of VOC emissions per year

Record-keeping and reporting requirements for surface coating or printing lines:

This facility shall maintain monthly records which list the following information for each surface coating or ink employed in this source.

- (a) the company identification of the surface coating;
- (b) the number of gallons employed;
- (c) the VOC content, in pounds of VOC per gallon of coating;
- (d) the VOC content, in pounds of VOC per gallon of coating, minus water;
- (e) the water content, in percent by volume; and
- (f) the nonvolatile (solids) content, in percent by volume.

These monthly records, as well as any supporting coating or ink analyses and computations, shall be retained in the company's files for a period of not less than two years and shall be made available to the Director or any authorized representative of the Director for review during normal business hours.

This facility shall submit semiannual reports to the Ohio EPA field office which summarize the following information for each coating employed in this source during the previous six calendar months: company identification of the surface coating, the total number of gallons employed, the VOC content (in pounds VOC per gallon of coating, minus water), the water content and the nonvolatile (solids) content. The reports shall be submitted by February 15 and August 15 of each year and shall cover the previous six months (July through December and January through June, respectively).

Solid, semi-solid or hazardous materials generated by the unit operations are to be reused, recycled or sold for recovery when feasible. Solid, semi-solid and hazardous waste must be stored, treated or disposed of in facilities installed and operated in accordance with Ohio Revised Code Section 3734.

The Southeast District Office of the Ohio Environmental Protection Agency shall be notified, in writing prior to start-up of operations, as to the proposed disposition of all solid, semi-solid and hazardous waste materials.

Notification shall include the following information:

- a. Name, location, and address of disposal facility.
- b. Method of disposal (incineration, secure landfill, etc.).
- c. Description of waste material to be disposed of.
- d. Quantities of waste material to be disposed of and frequency of disposal.
- e. Name and address of contract haulers.

Any change in the disposition of waste materials shall be reported to the District Office prior to such a change.
