This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. **Part II - Special Terms and Conditions**

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

**B. Operational Restrictions**

**C. Monitoring and/or Record Keeping Requirements**

1. The permittee shall collect and record the following information each month for the line:
  - a. The name and identification number of each coating, as applied.
  - b. The VOC content of each coating (excluding water and exempt solvents), as applied.
  - c. The number of gallons (excluding water and exempt solvents) of each coating employed.
  - d. The name and identification of each cleanup material employed.
  - e. The VOC content of each cleanup material, in pounds per gallon.
  - f. The number of gallons of each cleanup material employed.
  - g. The total VOC emissions from all coatings and cleanup materials employed, in pounds per month.

**D. Reporting Requirements**

1. The permittee shall notify the Director (the appropriate Ohio EPA District Office or local air agency) in writing of any monthly record showing the use of noncomplying coatings (for VOC content). The notification shall include a copy of such record and shall be sent to the Director (the appropriate Ohio EPA District Office or local air agency) within 30 days following the end of the calendar month.

**E. Testing Requirements**

1. Compliance with the emission limitations specified in section A.1. shall be determined in accordance with the following method(s):
 

Emission Limitation-  
93.1 lbs VOC/month, including cleanup

Applicable Compliance Method-  
Compliance shall be based upon the record keeping requirements specified in Section C.  
Emission Limitation-  
0.56 TPY VOC, including cleanup

**Applicable Compliance Method-**

Compliance shall be based upon the record keeping requirements specified in Section C. and shall be the sum of the 12 monthly VOC emission rates for the calendar year.

**Emission Limitation-**

3.0 pounds VOC per gallon of coating, excluding water and exempt solvents [for miscellaneous metal coatings not regulated under paragraphs (U)(1)(a) to (U)(1)(h) of OAC rule 3745-21-09]

**Applicable Compliance Method-**

Compliance shall be based upon the record keeping requirements specified in Section C. If required, USEPA Reference Methods 24 and 24A shall be used to determine the VOC contents for coatings. If the permittee determines that Method 24 or 24 A cannot be used for a particular coating, the permittee shall so notify the Administrator of the USEPA and shall use formulation data for that coating to demonstrate compliance until the USEPA provides alternative analytical procedures or alternative precision statements for Method 24 or 24A.
