This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. **Part II - Special Terms and Conditions**

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

**A. Applicable Emissions Limitations and/or Control Requirements**

1. 2. **Additional Terms and Conditions**
  - (b) The 13.40 lbs/hr emissions limit was established for PTI purposes to reflect the potential to emit for this emissions unit. Therefore, it is not necessary to develop record keeping and reporting requirements to ensure compliance with this limit.

**B. Operational Restrictions**

**C. Monitoring and/or Record Keeping Requirements**

1. The permittee shall collect and record the following information each month for this emission unit to determine annual VOC emissions:
  - a. The name and identification number of each coating, as applied.
  - b. The VOC content of each coating, as applied, in pounds per gallon.
  - c. The number of gallons of each coating employed.
  - d. The name and identification of each cleanup material employed.
  - e. The VOC content of each cleanup material, in pounds per gallon.
  - f. The number of gallons of each cleanup material employed.
  - g. The total VOC emissions from all coatings and cleanup materials employed, in pounds or tons.

**D. Reporting Requirements**

1. The permittee shall also submit annual reports which specify the total VOC emissions from this emissions unit for the previous calendar year. These reports shall be submitted by January 31 of each year.

**E. Testing Requirements**

1. Compliance with the emission limitations in Section A.I. of these terms and conditions shall be determined in accordance with the following methods:  
 Emission Limitation-  
 13.40 lbs/hr of VOC (excluding cleanup)  
  
 Applicable Compliance Method-  
 Compliance shall be determined by multiplying the maximum hourly coating usage by the maximum VOC content of the coatings employed in this emissions unit.

Emissions Limitation -  
13.05 tons/year VOC (including cleanup)

Applicable Compliance Method -  
Compliance shall be based upon record keeping as specified in section C.1. and shall be the summation of the 12 monthly VOC emission rates for the calendar year divided by 2000 lbs/ton.

2. Formulation data or USEPA Method 24 shall be used to determine the volatile organic compound contents of the coatings and cleanup materials.
