This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

A. Applicable Emissions Limitations and/or Control Requirements

1. Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be employed. 2. Additional Terms and Conditions

B. Operational Restrictions

1. The maximum daily coating usage for this emissions unit shall not exceed 8 gallons.
2. The maximum annual coating usage for this emissions unit shall not exceed 200 gallons.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for the coating line:
 - a. The name and identification number of each coating employed.
 - b. The volume, in gallons, of each coating employed.
 - c. The total volume, in gallons, of all of the coatings employed.
 - d. The VOC content of each coating, as applied, in pounds per gallon.
 - e. The total VOC emissions from all coatings employed, in pounds or tons.

D. Reporting Requirements

1. The permittee shall notify the Director (the appropriate Ohio EPA District Office or local air agency) in writing of any daily record showing that the coating line employs more than the applicable maximum daily coating usage limit. The notification shall include a copy of such record and shall be sent to the Director (the appropriate Ohio EPA District Office or local air agency) within 45 days after the exceedance occurs.
2. In accordance with paragraph 3 of the General Terms and Conditions, the permittee shall also submit deviation (excursion) reports to the Director (the appropriate Ohio EPA District Office or local air agency) which identify each day during which the VOC emissions from emissions unit K001 did not comply with the daily limit stated above, and the actual annual VOC emissions for each such day.
3. The permittee shall submit annual reports that identify any exceedances of the 200 gallons per year coating usage limitation, as well as the corrective actions that were taken to achieve compliance. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

1. Formulation data or USEPA Method 24 shall be used to determine the volatile organic compound content of the coatings used in this emissions unit.
2. Compliance with the emission limitation(s) in Section A.1. of this permit shall be determined in accordance with the following method(s):

Emission Limitation-
50.16 lbs VOC/day, excluding cleanup

Applicable Compliance Method-

Compliance shall be based upon the maximum daily coating usage of 8 gallons times the maximum VOC content of any coating employed in this emissions unit. Compliance can also be based upon the record keeping requirements specified in Section C.1.

Emission Limitation-
1.0 TPY VOC, excluding cleanup

Applicable Compliance Method-

Compliance shall be based upon the record keeping requirements specified in Section C.1. by summing all of the daily emissions rates for the calendar year.

Emission Limitation-
8 gallons of coating/day

Applicable Compliance Method-

Compliance shall be based upon the record keeping requirements specified in Section C.1.

1. The facility is hereby notified that this permit, and all agency records concerning the operation of this permitted source are subject to public disclosure in accordance with OAC rule 3745-49-03.
