This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

1. 2. Additional Terms and Conditions

- (a) The hourly emission limitation was established to reflect the potential to emit for this emissions unit. Therefore, it is not necessary to develop record keeping and/or reporting requirements to ensure compliance with this limit. The aggregate materials processed through the conveyors shall have a moisture content sufficient to minimize visible emissions of fugitive dust from the conveyors and transfer points so that compliance with the opacity requirement(s) specified above is continuously maintained.

B. Operational Restrictions

1. The maximum annual production rate for this facility shall not exceed 1,393,200 tons.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall maintain monthly records of the total aggregate materials produced by this facility.

D. Reporting Requirements

1. The permittee shall submit annual reports that identify any exceedances of the annual production rate limitation for the facility, as well as the corrective actions that were taken to achieve compliance. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

1. Compliance with the emission limitations in section A.1 of these terms and conditions shall be determined in accordance with the following methods:
Emission Limitation-
0.05 lb/hr particulates

Applicable Compliance Method-
Compliance shall be determined by multiplying the maximum hourly production rate of 450 tons/hour by the particulate emission factor of 1.008 E-4 lb/ton which is calculated by multiplying the AP-42 emission factor for PM10, as specified in USEPA reference document AP-42, Table 11.19.2-2 (1/95), by 2.1.

Emission Limitation-
0.07 TPY particulates

Applicable Compliance Method-

Compliance shall be based upon the record keeping specified in A.1., summing the 12 monthly production records for the calendar year, and then multiplying the sum by the emission factor of 1.008 E-4 lb/ton which is

calculated by multiplying the emission factor for PM10 as specified in Table 11.19.2-2 of AP-42 (1/95), by 2.1, and dividing by 2,000 pounds per ton.

Emission Limitation-
10% opacity, as a 6-minute average

Applicable Compliance Method-
Compliance shall be determined by visible emission evaluations performed using the methods and procedures specified in USEPA Reference Method 9.
