This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. B. Operational Restrictions

1. The pressure drop across the baghouse shall be maintained within the range of 1 to 4 inches of water while the emissions unit is in operation.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall properly operate and maintain equipment to monitor the pressure drop across the baghouse while the emissions unit is in operation. The monitoring equipment shall be calibrated, operated, and maintained in accordance with the manufacturer's recommendations, instructions, and operating manual(s). The permittee shall record the pressure drop across the baghouse on a daily basis when the emissions unit is in operation.

D. Reporting Requirements

1. The permittee shall submit pressure drop deviation (excursion) reports that identify all periods of time during which the pressure drop across the baghouse did not comply with the allowable range specified above.

The deviation (excursion) reports shall be submitted in accordance with paragraph 3 of the General Terms and Conditions.

E. Testing Requirements

1. Compliance with the emission limitation(s) in Section A.1. of these terms and conditions shall be determined in accordance with the following method(s):
 - Emission Limitation - 0.551 lb/hour PE
 - Applicable Compliance Method - If required, compliance shall be demonstrated in accordance with the methods and procedures specified in OAC rule 3745-17-03(B)(10).
 - Emission Limitation - 2.41 TPY particulates
 - Applicable Compliance Method - The 2.41 TPY limitation was developed by multiplying the 0.551 lb/hour limitation by the maximum annual operating schedule of 8,760, and then dividing by 2,000. Therefore, provided compliance is shown with the hourly limitation, compliance shall also be shown with the annual limitation.
 - Emission Limitation - 5% opacity, as a six-minute average

Applicable Compliance Method -
Compliance shall be determined by visible emission evaluations performed in accordance with OAC rule 3745-17-03(B)(3) using the methods and procedures specified in USEPA Reference Method 9.
