This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

A. Applicable Emissions Limitations and/or Control Requirements

1. The specific operation(s), property, and/or equipment which constitute this emissions unit are listed in the following table along with the applicable rules and/or requirements and with the applicable emissions limitations and/or control measures. Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be employed. Additional applicable emissions limitations and/or control measures (if any) may be specified in narrative form following the table.

2. Additional Terms and Conditions

- (a) The hourly emission limitation was established to reflect the potential to emit for this emissions unit. Therefore, it is not necessary to develop record keeping and/or reporting requirements to ensure compliance with this limit. The permittee shall employ the wet suppression system whenever this emissions unit is in operation to minimize or eliminate visible emissions of fugitive dust. The visible particulate emission limitation required by OAC rule 3745-17-07 is less stringent than the visible particulate emission limitation established in accordance with the requirements specified in 40 CFR Part 60, Subpart 000.

B. Operational Restrictions

1. The permittee shall operate this emissions unit no more than 6720 hours per year.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall maintain monthly records of the amount of aggregate produced at this plant, in tons.
2. The permittee shall maintain monthly records of the total hours of operation for this emissions unit.

D. Reporting Requirements

1. The permittee shall submit annual reports that identify any exceedances of the annual hours of operation limitation, as well as the corrective actions that were taken to achieve compliance. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

1. Compliance with the emission limitations in Section A.1. shall be determined in accordance with the following method(s):
Emission Limitation:
1.68 lbs/hr of particulates

Applicable Compliance Method:

Compliance shall be determined by multiplying the maximum hourly production of 200 tons/hour by the particulate emission factor of 0.0084 lb/ton, as specified in USEPA Reference Document AP-42, Table 11.19.2-2.
Emission Limitation:

5.6 tpy of particulates

Applicable Compliance Method:

Compliance shall be demonstrated based upon record keeping specified in section C.1., summing the 12 monthly hours of operation records for the calendar year, and then multiplying the sum by the hourly emission rate of 1.68 pounds particulates per hour, and dividing by 2,000 pounds per ton.

Emission Limitation:

10% opacity as a 6-minute average

Applicable Compliance Method:

Compliance shall be determined by visible emission evaluations performed in accordance with OAC rule 3745-17-03(B)(3) using the methods and procedures specified in USEPA Reference Method 9 and 40 CFR 60.675 (c), Subpart OOO.

F. Miscellaneous Requirements

1. Notice to Relocate a Portable or Mobile Source

Pursuant to Ohio Administrative Code (OAC) rule 3745-31-03(A)(1)(p)(i), the permittee of a portable or mobile emissions unit may relocate within the State of Ohio without first obtaining a PTI providing the following criteria are met:

i. the portable emissions unit is equipped with the best available control technology for such portable emissions unit;

ii. the portable emissions unit is operating pursuant to a currently effective permit to operate (PTO);

iii. the applicant has provided proper notice of intent to relocate the portable emissions unit to the RAPCA and the appropriate field office having jurisdiction over the new site within a minimum of thirty days prior to the scheduled relocation; and

iv. in RAPCA's and the appropriate field office's judgement, the proposed site is acceptable under the rule 3745-15-07 of the Administrative Code.

In the alternative, pursuant to OAC rule 3745-31-03(A)(1)(p)(ii), the permittee of a portable or mobile emissions unit may relocate within the State of Ohio without first obtaining a PTI providing the following criteria of OAC rule 3745-31-05(F) are met:

i. the portable emissions unit permittee possesses an Ohio EPA PTI, PTO or registration status;

ii. the portable emissions unit is equipped with best available technology;

iii. the portable emission unit owner has identified the proposed site to Ohio EPA;

iv. Ohio EPA has determined that the portable emissions unit, at the proposed site, will have an acceptable environmental impact;

v. a public notice, consistent with Chapter 3745-47 of the Administrative Code, is published in the county where the proposed site is located;

vi. the owner of the proposed site has provided the portable emissions unit owner with approval or equivalent declaration that it is acceptable to the site owner to move the portable emissions unit to this proposed site; and

vii. the portable emissions unit owner has provided Ohio EPA with fifteen days written notice of the relocation.

Any site approvals issued by the Ohio EPA, pursuant to F.1.a or F.1.b above, shall be valid for no longer than three years and are subject to renewal.

In order for the RAPCA and the appropriate field office having jurisdiction over the new site to determine compliance with all of the above criteria, the owner or operator of the portable or mobile emissions unit must file a "Notice of Intent to Relocate", within the specified time frame (30 or 15 days) prior to the relocation of the emissions unit with the RAPCA (451 W. Third Street, Dayton, OH 45422) and the appropriate field office having jurisdiction over the new site. Upon receipt of the notice, the RAPCA and/or appropriate field office having jurisdiction over the new site, will evaluate the request in accordance with the above criteria.

Failure to submit said notification and to receive Ohio EPA approval prior to relocation of the emissions unit may result in fines and civil penalties.

2. The permittee is hereby notified that this permit and all agency records concerning the operation of this permitted emissions unit are subject to public disclosure in accordance with OAC rule 3745-49-03.
