This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

A. Applicable Emissions Limitations and/or Control Requirements

1. The specific operation(s), property, and/or equipment which constitute this emissions unit are listed in the following table along with the applicable rules and/or requirements and with the applicable emissions limitations and/or control measures. Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be employed. Additional applicable emissions limitations and/or control measures (if any) may be specified in narrative form following the table.

B. Operational Restrictions

1. The maximum annual operating hours for this emissions unit shall not exceed 3,900 hours.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall perform daily checks, when the emissions unit is in operation and when the weather conditions allow, for any visible particulate emissions from the stack serving this emissions unit. The presence or absence of any visible emissions shall be noted in an operations log. If visible emissions are observed, the permittee shall also note the following in the operations log:
 - a. the color of the emissions;
 - b. whether the emissions are representative of normal operations;
 - c. if the emissions are not representative of normal operations, the cause of the abnormal emissions;
 - d. the total duration of any visible emission incident; and
 - e. any corrective actions taken to minimize or eliminate the visible emissions.

If visible emissions are present, a visible emission incident has occurred. The observer does not have to document the exact start and end times for the visible emission incident under item (d) above or continue the daily check until the incident has ended. The observer may indicate that the visible emission incident was continuous during the observation period (or, if known, continuous during the operation of the emissions unit). With respect to the documentation of corrective actions, the observer may indicate that no corrective actions were taken if the visible emissions were representative of normal operations, or specify the minor corrective actions that were taken to ensure that the emissions unit continued to operate under normal conditions, or specify the corrective actions that were taken to eliminate abnormal visible emissions.

2. The permittee shall maintain monthly records of the following information:
 - a. The operating hours for this emissions unit.

- b. The amount of tires processed.
- c. The controlled PE emissions rate in tons.

D. Reporting Requirements

- 1. The permittee shall submit semiannual written reports that (a) identify all days during which any visible particulate emissions were observed from the stack serving this emissions unit and (b) describe any corrective actions taken to minimize or eliminate the visible particulate emissions. These reports shall be submitted to the Director (the appropriate Ohio EPA District Office or local air agency) by January 31 and July 31 of each year and shall cover the previous 6-month periods.
- 2. The permittee shall submit annual reports which identify any exceedances of the annual operating hours limitation, as well as the corrective actions that were taken to achieve compliance. These reports shall be submitted by January 31 of each year.
- 3. The permittee shall submit annual reports that specify the actual total PE emissions from this emissions unit, for the previous calendar year. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

- 1. Compliance with the emission limitations in Section A.1. of these terms and conditions shall be determined in accordance with the following methods:
 - Emission Limitation:
The particulate emissions (PE) from this emissions unit shall not exceed 5.04 lbs/hr.
 - Applicable Compliance Method:
The emission limitation was based upon the emission factor from AP 42, "Compilation of Air Pollution Emission Factors", 5th Edition, Table 4.12-12 (Draft 6/99). Compliance with the lb/hr limitation may be determined by multiplying the maximum rubber removed (12 lbs rubber/tire) by the maximum tires processed (35 tires/hr) by the emission factor (0.545 lb/lb rubber) by a control efficiency of (1- 0.978).
 - If required, the permittee shall demonstrate compliance with the lb/hr emission limitation through emission testing performed in accordance with OAC rule 3745-17-03(B)(10).
 - Emission Limitation:
The particulate emissions (PE) from this emissions unit shall not exceed 9.82 tons/yr.
 - Applicable Compliance Method:
Compliance shall be based upon the record keeping requirements specified in Section C.2. of this permit and shall be the summation of the 12 monthly PE emissions rates for the calendar year.
 - Emission Limitation:
Visible particulate emissions from any stack shall not exceed twenty per cent opacity as a six-minute average.
 - Applicable Compliance Method:
Compliance shall be determined through visible emission observations performed in accordance with 40 CFR Part 60, Appendix A, Method 9 and the procedures specified in OAC rule 3745-17-03(B)(1).
