This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

B. Operational Restrictions

1. The maximum daily coating usage for this emissions unit shall not exceed 10 gallons.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for the coating operation:
 - a. The name and identification number of each coating employed.
 - b. The volume, in gallons, of each coating employed.
 - c. The total volume, in gallons, of all of the coatings employed.
2. The permittee shall collect and record the following information for the purpose of determining annual VOC emissions:
 - a. The name and identification of each cleanup material employed.
 - b. The number of gallons of each cleanup material employed.
 - c. The VOC content of each cleanup material, in pounds per gallon.
 - d. The VOC content of each coating, as applied, in pounds per gallon.
 - e. The total VOC emissions from all coatings and cleanup materials employed, in pounds or tons.
3. The permittee shall maintain daily records of the coating usage in this emissions unit.

D. Reporting Requirements

1. The permittee shall submit quarterly deviation (excursion) reports which include an identification of whether the daily coating usage exceeds 10 gallons and the actual coating usage for that day.

The quarterly deviation (excursion) reports shall be submitted in accordance with paragraph 3.b. of the General Terms and Conditions.

E. Testing Requirements

1. Compliance with the emission limitation(s) in Section A.I. of these terms and conditions shall be determined in accordance with the following method(s):
Emission Limitation:
48.4 lbs VOC/day (excluding cleanup)

Applicable Compliance Method:
Compliance shall be determined by multiplying the maximum daily coating usage of 10 gallons times the maximum VOC content of any coating employed in this emissions unit. Compliance can also be based upon the record keeping specified in (C)(1).
Emission Limitation:
7.25 TPY VOC (including cleanup)

Applicable Compliance Method:

Compliance shall be based upon the record keeping specified in (C)(1) & (2).

2. Formulation data or USEPA Method 24 shall be used to determine the organic compound contents of the coatings and cleanup material.

F. Miscellaneous Requirements

1. The facility is hereby notified that this permit, and all agency records concerning the operation of this permitted source are subject to public disclosure in accordance with OAC rule 3745-49-03.
2. The following terms and conditions shall supersede all air pollution control requirements for this emissions unit contained in permit to install 08-3087, as issued on August 3, 1994: A.1., C.1-2., D.1., and F.1.
