This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

B. Operational Restrictions

1. The maximum annual operating hours for this emissions unit shall not exceed 6240.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall maintain monthly records of the operating hours for this emissions unit.

D. Reporting Requirements

1. The permittee shall submit annual reports which identify any exceedances of the annual operating hours limitation, as well as the corrective actions that were taken to achieve compliance. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

1. Compliance with the emission limitation(s) in Section A.I. of these terms and conditions shall be determined in accordance with the following method(s):
 - Emission Limitation-
0.40 lb/hr Particulate Matter
 - Applicable Compliance Method-
If required, compliance with this mass emission limitation shall be based on stack testing per OAC rule 3745-17-03(B)(8).
 - Emission Limitation-
1.25 TPY Particulate Matter
 - Applicable Compliance Method-
Compliance with this annual emission limit shall be determined by multiplying the 0.40 lb/hr limitation or the actual tested hourly emission rate by the actual number of annual operating hours per year, divided by 2000 lbs/ton.
 - Emission Limitation-
5% opacity visible emission limitation
 - Applicable Compliance Method-
Compliance shall be determined by visible emission evaluations performed in accordance with OAC rule 3745-17-03(B)(5) using the methods and procedures specified in USEPA Method 9.

F. Miscellaneous Requirements

1. The facility is hereby notified that this permit, and all agency records concerning the operation of this permitted emissions unit are subject to public disclosure in accordance with OAC rule 3745-49-03.
