This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

B. Operational Restrictions

1. The pressure drop across the baghouse shall be maintained within the range of four to nine inches (4" - 9") water while this emission unit is in operation.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall properly install, operate, and maintain equipment to monitor the pressure drop across the baghouse while the emissions unit is in operation. The monitoring equipment shall be installed, calibrated, operated, and maintained in accordance with the manufacturer's recommendations, instructions, and operating manual(s). The permittee shall record the pressure drop across the baghouse daily.

D. Reporting Requirements

1. Any baghouse pressure drop readings less than four inches or greater than nine inches shall be reported to the Cleveland Bureau of Air Pollution Control within 48 hours of the reading.

E. Testing Requirements

1. Compliance with visible emissions limitations in Section A.1 shall be verified using Method 9 pursuant to OAC rule 3745-17-03(B)(1).
2. Compliance with the particulate matter and sulfur dioxide emission limitations in Section A.1 shall be verified by a stack test at the request of Ohio EPA.

F. Miscellaneous Requirements

1. None
