This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

A. Applicable Emissions Limitations and/or Control Requirements

1. Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be employed. 2. **Additional Terms and Conditions**
 - (a) The VOC content of each coating employed shall not exceed 2.7 pounds per gallon, as applied.

B. Operational Restrictions

1. The amount of coatings employed in this emissions unit shall not exceed 1 gallon per day and 140.7 gallons per year.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for the coating line:
 - a. The name and identification of each coating employed.
 - b. The VOC content of each coating, as applied, in pounds per gallon.
 - c. The volume, in gallons, of all coatings employed.

D. Reporting Requirements

1. The permittee shall notify the Director of any daily record which shows an exceedance of the VOC content and/or usage limits. A copy of each such record shall be sent to the Director within 45 days after the exceedance occurs.

E. Testing Requirements

1. USEPA Methods 24 and 24A shall be used to determine the VOC content for (a) coatings and (b) flexographic and rotogravure printing lines and related coatings, respectively. If, pursuant to section 4.3 of Method 24,40 CFR Part 60, Appendix A, an owner or operator determines that Method 24 or 24A cannot be used for a particular coating or ink, the permittee shall so notify the Administrator of the USEPA and shall use formulation data for that coating or ink to demonstrate compliance until the USEPA provides alternative analytical procedures or alternative precision statements for Method 24 or 24A.
2. See T&C C.1 for compliance with the VOC content and usage limitations.

F. Miscellaneous Requirements

1. The following terms and conditions shall supersede all the air pollution control requirements for this emissions unit contained in permit to install 14-2457 as issued on 11-6-91: A-E.
