This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

A. Applicable Emissions Limitations and/or Control Requirements

1. 2. Additional Terms and Conditions

- (a) The OC content (as applied) of each coating employed in this emissions unit shall not exceed 6.2 pounds of VOC per gallon of coating, excluding water and exempt solvents.
The OC content of each cleanup material employed in this emissions unit shall not exceed 6.71 pounds of VOC per gallon of cleanup.

B. Operational Restrictions

1. The coating usage shall not exceed 2.4 gallons/day and 600 gallons/year.
2. The cleanup usage shall not exceed 3 gallons/day and 450 gallons/year.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day :
 - a. The name and identification of each coating and cleanup material employed.
 - b. The OC content of each coating (in lbs/gallon, excluding water and exempt solvents) and cleanup material (in pounds per gallon), as applied.
 - c. The number of gallons of each coating and cleanup material employed.
 - d. The total number of gallons of all coatings and all cleanup materials employed.
 - e. The total OC emissions from all coatings and cleanup materials employed, in pounds.

D. Reporting Requirements

1. The permittee shall notify the Hamilton County Department of Environmental Services in writing of any daily record showing an exceedance of the emission and /or usage limitations as outlined in this permit. The notification shall include a copy of such record and shall be sent to the Hamilton County Department of Environmental Services within 30 days following the end of the calendar month.

E. Testing Requirements

1. Compliance with the usage and emission limitations shall be demonstrated by term C.

2. Formulation data or USEPA method 24 (for coatings) or 24A (for flexographic and rotogravure printing inks and related coatings) shall be used to determine the OC contents of the coatings and cleanup materials.
