This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. **Part II - Special Terms and Conditions**

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

**A. Applicable Emissions Limitations and/or Control Requirements**

1. **2. Additional Terms and Conditions**

- (a) 7.07 lbs VOC/gallon coating, excluding water and exempt solvents.

**C. Monitoring and/or Record Keeping Requirements**

1. The permittee shall collect and record the following information each month for the line:
  - a. The name and identification number of each coating and cleanup material employed.
  - b. The VOC content of each coating (excluding water and exempt solvents) and each cleanup material employed, in pounds per gallon.
  - c. The number of gallons of each coating (excluding water and exempt solvents) and cleanup material employed.
  - d. The total VOC emissions from all coatings, i.e., the sum of b times c for all coatings employed divided by 2000, in tons.
  - e. The total VOC emissions, i.e., the sum of b times c for all coatings and cleanup materials employed divided by 2000, in tons.

**D. Reporting Requirements**

1. The permittee shall notify the Director (Hamilton County Dept. of Env. Services) of any monthly record which shows an exceedance of the VOC content limits and/or the VOC emission limits. A copy of each such record shall be submitted within 30 days of the exceedance.

**E. Testing Requirements**

1. USEPA Method 24 shall be used to determine the VOC content for each coating employed. If, pursuant to section 4.3 of Method 24, 40 CFR Part 60, Appendix A, an owner or operator determines that Method 24 cannot be used for a particular coating, the permittee shall so notify the Administrator of the USEPA and shall use formulation data for that coating to demonstrate compliance until the USEPA provides alternative analytical procedures or alternative precision statements for Method 24.
2. Formulation data shall be used to determine the VOC content of each cleanup material employed.
3. Compliance with the VOC emissions limits shall be demonstrated by the sum of the monthly VOC emissions in C.1.

F. **Miscellaneous Requirements**

1. The following terms and conditions shall supersede all the air pollution control requirements for this emissions unit contained in permit to install 14-1496 as issued on 4/27/88: A-E.
