This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.
 - (a) None.
2. For the purpose of a permit-to-operate document, the emissions unit terms and conditions identified below are enforceable under state law only with the exception of those listed below which are federally enforceable.

A. Applicable Emissions Limitations and/or Control Requirements

1. The specific operation(s), property, and/or equipment which constitute this emissions unit are listed in the following table along with the applicable rules and/or requirements and with the applicable emissions limitations and/or control measures. Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be employed. Additional applicable emissions limitations and/or control measures (if any) may be specified in narrative form following the table.

2. **Additional Terms and Conditions**
 - (a) The VOC content of each coating employed in this emissions unit shall not exceed 1.07 pounds of VOC per gallon of coating, excluding water and exempt solvents, as a daily volume-weighted average, as applied.
The emissions limitation required by this applicable rule is less stringent than the emissions limitation established by best available technology under OAC rule 3745-31-05.

B. Operational Restrictions

1. The permittee shall employ no more than 10,841 gallons of coatings, excluding water and exempt solvents, per calendar year in this emissions unit.
2. The permittee shall employ no more than 5 gallons of methylene chloride per calendar day in this emissions unit.
3. The permittee shall employ no more than 1,825 gallons of methylene chloride per calendar year in this emissions unit.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for the line:
 - a. the name and identification number of each coating, as applied;
 - b. the VOC content (excluding water and exempt solvents) and the number of gallons (excluding water and exempt solvents) of each coating, as applied;
 - c. the daily volume-weighted average VOC content of all coatings, as applied, calculated in accordance with the equation specified in paragraph (B)(9) of OAC rule 3745-21-10 for CVOC₂; and
 - d. the number of gallons of methylene chloride employed.
2. The permittee shall collect and record the following information for the purpose of determining annual VOC emissions:
 - a. the name and identification of each cleanup material employed;
 - b. the number of gallons of each cleanup material employed;
 - c. the VOC content of each cleanup material, in pounds per gallon; and
 - d. the total VOC emissions from all coatings and cleanup materials, in tons .

D. Reporting Requirements

1. The permittee shall notify the Hamilton County Department of Environmental Services in writing of any daily record showing that the daily volume-weighted average VOC content exceeded the applicable limitation, or that the coating line employed more than the applicable maximum daily methylene chloride usage limit. The notification shall include a copy of such record and shall be sent to the Hamilton County Department of Environmental Services within 45 days after the exceedance occurs.

The permittee shall also submit annual reports which specify the total VOC emissions from this emissions unit, and the number of gallons of coatings and methylene chloride employed in this emissions unit, for the previous calendar year. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

1. Emission Limitation:

1.07 lbs of VOC per gallon of coating

Applicable Compliance Method:

Compliance with this VOC emission limitation shall be demonstrated by U.S. Environmental Protection Agency Method 24 and the record keeping in C.1.

Emission Limitation:

15.85 tpy VOC

Applicable Compliance Method:

Compliance with this yearly VOC emission limitation shall be demonstrated based upon the record keeping requirements in section C.2 of this permit.

Emission Limitation:

10,841 gallons per year of coating

Applicable Compliance Method:

Compliance with the yearly usage limitations shall be demonstrated based upon the record keeping requirements in section C.1 of this permit. The daily usage of all coating materials, excluding water and exempt solvents, in gallons, shall be added together for each day of the calendar year.

Emission Limitation:

5 gallons per day of methylene chloride
1,825 gallons per year of methylene chloride

Applicable Compliance Method:

Compliance with the daily and yearly usage limitations shall be demonstrated based upon the record keeping requirements in section C.1 of this permit.
