This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

B. Operational Restrictions

1. The annual usage of coatings shall not exceed 350 gallons per year.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall maintain monthly records of the following:
 - a. The name and identification number of each coating and cleanup material employed.
 - b. The gallons of each coating and cleanup material employed, as applied.
 - c. The total gallons of all coatings employed, as applied.
 - d. The VOC content of each coating, in pounds per gallon and in pounds per gallon excluding water and exempt solvents, and each cleanup material, in pounds per gallon.
 - e. The total VOC emissions, i.e., the sum of b times d for all coatings and cleanup materials employed divided by 2000, in tons.

D. Reporting Requirements

1. The permittee shall notify the Director (the appropriate Ohio EPA District Office or local air agency) in writing of any monthly record showing the use of noncomplying coatings. The notification shall include a copy of each such record and shall be sent to the Director (the appropriate Ohio EPA District Office or local air agency) within 45 days after the exceedance occurs.
2. The permittee shall also submit annual reports which specify the total gallons of all coatings employed and the total VOC emissions for the previous calendar year. These reports shall be submitted by January 31 of each year.

E. Testing Requirements

1. USEPA Method 24 shall be used to determine the VOC content for each coating employed. If, pursuant to section 4.3 of Method 24, 40 CFR Part 60, Appendix A, an owner or operator determines that Method 24 cannot be used for a particular coating, the permittee shall so notify the Administrator of the USEPA and shall use formulation data for that coating to demonstrate compliance until the USEPA provides alternative analytical procedures or alternative precision statements for Method 24.
2. Formulation data shall be used to determine the VOC content of each cleanup material employed.
3. Compliance with the coating VOC content limit shall be demonstrated by the record keeping requirements in C.1.

4. Compliance with the annual VOC emission limit and coating usage limit shall be demonstrated by a summation of the monthly records required in C.1.
