This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

B. Operational Restrictions

1. The following usage limitations shall not be exceeded for this emission unit:
 - i. 18.25 gallons/year of enamel paint;
 - ii. 52 gallons/year of epoxy paint; and
 - iii. 23 gallons/year of cleanup material.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for the coating line:
 - i. The name and identification number of each coating employed.
 - ii. The VOC content of each coating, as applied, in pounds per gallon.
 - iii. The volume, in gallons, of each coating employed.
 - iv. The total volume, in gallons, of all of the coatings employed.

The permittee shall collect and record the following information each month:

- i. The name and identification of each cleanup material employed.
- ii. The number of gallons of each cleanup material employed.
- iii. The VOC content of each cleanup material, in pounds per gallon.
- iv. The total VOC emissions from all coatings and cleanup materials employed, in pounds or tons per month.

D. Reporting Requirements

1. The permittee shall notify the Director of any daily record showing that the coating line employs more than the applicable maximum daily coating usage limit. A copy of such record shall be sent to the Director within 45 days after the exceedance occurs.

E. Testing Requirements

1. Compliance with the emission limitation(s) in Section A.1. of these terms and conditions shall be determined in accordance with the following method(s):

i. Compliance with the emission limitations shall be demonstrated by multiplying the number of gallons of each type of surface coating and cleanup material by the solvent content of each type of coating and cleanup material.

ii. The VOC content shall be determined by "OAC rule 3745-21-10(B). USEPA Methods 24 and 24A shall be used to determine the VOC contents for (a) coatings and (b) flexographic and rotogravure printing inks and related coatings, respectively. If, pursuant to section 4.3 of Method 24, 40 CFR Part 60, Appendix A, an owner or operator determines that Method 24 or 24A cannot be used for a particular coating or ink, the permittee shall so notify the Administrator of the USEPA and shall use formulation data for that coating or ink to demonstrate compliance until the USEPA provides alternative analytical procedures or alternative precision statements for Method 24 or 24A.
