However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. 1. The average daily throughput, based upon the number of days during the calendar year when the bulk plant was actually in operation, shall not be equal to or greater than 4,000 gallons of gasoline.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall maintain records of the days of operation and the total quantity of all gasoline loaded into tank trucks.
2. The permittee shall maintain records of the results of any leak checks, including, at a minimum, the following information:
 - a. the date of inspection;
 - b. the findings (may indicate no leaks discovered or location, nature, and severity of each leak);
 - c. the leak determination method;
 - d. the corrective action taken (date each leak repaired and reasons for any repair interval in excess of fifteen calendar days); and
 - e. the inspector's name and signature.

D. Reporting Requirements

1. If the records document an average daily throughput equal to or greater than 4,000 gallons per day, the permittee shall so notify the Director (the appropriate Ohio EPA District Office or local air agency) within 30 days of becoming aware of the occurrence.
2. If the records document any leaks in vapor or liquid lines that are not repaired within fifteen days after identification, the permittee shall so notify the Director (the appropriate Ohio EPA District Office or local air agency) within 30 days of becoming aware of the occurrence.
