This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. 2. Additional Terms and Conditions

- (a) The permittee shall operate and maintain a baghouse in accordance with the manufacturer's recommendations, instructions, and operating manual(s). The permittee shall operate and maintain hoods, fans and other equipment to adequately enclose, contain, capture, vent and control particulate matter generated from the operation of this emissions unit. The emissions limit based on this applicable rule is less stringent than the emissions limit established pursuant to OAC rule 3745-31-05.

B. Operational Restrictions

1. The pressure drop across the baghouse shall be maintained within the range of 0.5 to 8.0 inches of water while the emissions unit is in operation.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall properly install, operate, and maintain equipment to monitor the pressure drop across the baghouse while the emissions unit is in operation. The monitoring equipment shall be installed, calibrated, operated, and maintained in accordance with the manufacturer's recommendations, instructions, and operating manual(s). The permittee shall record the pressure drop across the baghouse on a daily basis.

D. Reporting Requirements

1. The permittee shall submit pressure drop deviation (excursion) reports that identify all periods of time during which the pressure drop across the baghouse did not comply with the allowable range specified above.
2. The deviation reports shall be submitted in accordance with the requirements specified in General Term and Condition 3.

E. Testing Requirements

1. Compliance with the emission limitations in Section A.1 of these terms and conditions shall be determined in accordance with the following methods:

4.4 lbs/hr of particulate matter

20% opacity as a 3-minute average, except as provided by rule
