This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

A. Applicable Emissions Limitations and/or Control Requirements

1. 2. Additional Terms and Conditions

- (a) Visible particulate emissions from any stack shall not exceed 20% opacity as a six minute average, except as specified by the rule. This incinerator and all associated equipment and grounds shall be designed, operated and maintained so as to prevent the emission of objectionable odors.

B. Operational Restrictions

1. Only properly trained personnel shall operate the incinerator.
2. The permittee shall ignite the afterburner 15 minutes prior to ignition of refuse and continue its use during the entire burn cycle.
3. The permittee shall operate and maintain the incinerator and all associated equipment so as to prevent the emission of objectionable odors.

D. Reporting Requirements

E. Testing Requirements

1. Compliance with the emission limitations in section A.1 of these Special Terms and Conditions shall be determined in accordance with the following methods:
Emission Limitation: 0.10 pound of particulate matter per 100 pounds refuse of material charged.

Applicable Compliance Method: If required, compliance with this mass emission limitation shall be based on stack testing per OAC rule 3745-17-03(B)(8).
Emission Limitation: Visible particulate emissions from any stack shall not exceed 20% opacity as a six minute average, except as specified by the rule.

Applicable Compliance Method: Compliance shall be determined through visible emission observations performed in accordance with 40 CFR Part 60, Appendix A, Method 9 and the procedures specified in OAC rule 3745-17-03 (B) (1).

F. Miscellaneous Requirements

1. The permittee shall post complete operating instructions for the proper use of the incinerator in a prominent place near the incinerator.
