This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

B. Operational Restrictions

1. None

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall collect and record the following information each day for this emissions unit:
 - a. The name and identification number of each coating employed.
 - b. The name and identification number of each cleanup material employed.
 - c. The VOC content of each coating (excluding water and exempt solvents) in pounds per gallon, as applied.
 - d. The VOC content of each cleanup material, in pounds per gallon, as applied.
 - e. The number of gallons of each cleanup material employed.
 - f. The number of gallons (excluding water and exempt solvents) of each coating employed.
 - g. The total VOC emissions from all coatings and cleanup materials employed, in pounds.

D. Reporting Requirements

1. The permittee shall notify the Director (the appropriate Ohio EPA District Office or local air agency) in writing of any daily record showing the use of noncomplying coatings or an exceedance of the daily VOC limit. The notification shall include a copy of such record and shall be sent to the Director (the appropriate Ohio EPA District Office or local air agency) within 30 days following the end of the calendar month in which the exceedance occurred.

E. Testing Requirements

1. Compliance with the emission limitations in section A.1 of these terms and conditions shall be determined in accordance with the following methods:
 - a. Emissions Limitation: 3.0 lbs/gal of VOC

Applicable Compliance Method: USEPA Methods 24 and 24A shall be used to determine the VOC contents for coatings. If, pursuant to section 4.3 of Method 24, 40 CFR Part 60, Appendix A, an owner or operator determines that Method 24 or 24A cannot be used for a particular coating, the permittee shall so notify the Administrator of the USEPA and shall use formulation data for that coating ink to demonstrate compliance until

the USEPA provides alternative analytical procedures or alternative precision statements for Method 24 or 24A.

b. Emissions Limitation: 35 lbs/day of VOC

Applicable Compliance Method: Compliance shall be determined based upon the recordkeeping specified in section C.1 of these terms and conditions.
