This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

Emissions of carbon monoxide (CO) from this emissions unit shall not exceed 0.36 pound per hour and 1.56 TPY.

E. Testing Requirements

1. Compliance with the emissions limitations in sections A.1. and A.2. of these terms and conditions shall be determined in accordance with the following methods:
Emissions Limitation: 0.25 pound particulate matter per million Btu of actual heat input.

Applicable Compliance Method: Compliance shall be based upon the use of an emission factor as specified in AP-42, 5th Edition, Compilation of Air Pollution Emission Factors, section 3.2, table 3.2-4.
Emissions Limitation: Visible particulate emissions from the exhaust stack serving this emissions unit shall not exceed twenty (20) percent opacity, as a six-minute average, except for a period of not more than six (6) consecutive minutes in any sixty-minute period. Visible particulate emissions shall not exceed sixty (60) percent opacity, as a six-minute average, at any time.

Applicable Compliance Method: Compliance shall be determined through visible emission observations in accordance with 40 CFR Part 60, Appendix A, Method 9 and the procedures specified in OAC rule 3745-17-03 (B)(1).
Emission Limitation: Emissions of nitrogen oxides (NOx) from this emissions unit shall not exceed 2.72 pound

per hour and 11.9 TPY.

Applicable Compliance Method: Use of emissions factor from AP-42, Fifth Edition, Table 3.2-1, the rated heat rate of engine, and the assumption of 8760 hours per year operation.

Emission Limitation: Emissions of total organic compound (OC) from this emissions unit shall not exceed 1.02 pound per hour and 4.47 TPY.

Applicable Compliance Method: Use of emissions factor from AP-42, Fifth Edition, Table 3.2-1, the rated heat rate of engine, and the assumption of 8760 hours per year operation.

Emission Limitation: Emissions of carbon monoxide (CO) from this emissions unit shall not exceed 0.36 pound per hour and 1.56 TPY.

Applicable Compliance Method: Use of emissions factor from AP-42, Fifth Edition, Table 3.2-1, the rated heat rate of engine, and the assumption of 8760 hours per year operation.
