This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

1. For the purpose of a permit-to-install document, the emissions unit terms and conditions identified below are federally enforceable with the exception of those listed below which are enforceable under state law only.

A. Applicable Emissions Limitations and/or Control Requirements

1. Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be employed. 2. Additional Terms and Conditions

- (a) This incinerator and all associated equipment and grounds shall be designed, operated and maintained so as to prevent the emission of objectionable odors.

B. Operational Restrictions

1. The incinerator shall be operated only by adequately trained personnel.
2. The permittee shall operate and maintain the incinerator in such a way as to meet all applicable engineering standards and practices and the recommendations of the manufacturer in order to minimize the air contaminant emission releases.
3. This unit shall not be used to dispose of infectious or medical waste as defined in OAC 3745-75-01(C)(4).
4. During a cremation burn, the temperature of the secondary combustion chamber shall be maintained at a minimum of 1600 degrees Fahrenheit.

5. The secondary combustion chamber shall be pre-heated for at least thirty (30) minutes prior to ignition of the charge and shall continue to be used during the entire burn cycle.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall operate and maintain a continuous temperature monitor and recorder for the secondary combustion chamber operating temperatures. The temperature monitor and recorder shall be installed, calibrated, operated and maintained in accordance with the manufacturers recommendations, instructions, and applicable operating manual(s).
2. The permittee shall maintain copies of the records of the secondary combustion chamber temperature at the facility for a period of at least five years. Those records should be made available for Ohio EPA or their representatives to review during normal working hours.

D. Reporting Requirements

1. The permittee shall submit temperature deviation (excursion) reports that identify all periods of time during which the secondary combustion chamber exhaust gas temperatures did not comply with the temperature limitation specified above, including:
 - the date of the excursion;
 - the time interval over which the excursion occurred;
 - the temperature values during the excursion;
 - the cause(s) for the excursion; and
 - the corrective action which has been or will be taken to prevent similar excursions in the future.
2. This report shall be sent to the Ohio EPA, Northeast District Office within forty-five (45) days of the excursion.

E. Testing Requirements

1. Compliance with the emissions limitations in Section A.1 of these terms and conditions shall be determined in accordance with the following methods:
Emissions Limitation:
Particulate emissions from this emission unit shall not exceed 0.15 lbs/hr and 0.66 tons per year.

Applicable Compliance Method:

The short term emissions (pounds per hour) shall be determined by the following equation:

$$PE \text{ (lb/hr)} = 0.10 \text{ lbs/100 lbs charged (OAC 3745-17-09(B))} * R$$

$$PE \text{ (tons/year)} = PE \text{ (lb/hr)} * 8760 \text{ hr/year} * 1/2000 \text{ lb/ton}$$

Where:

PE= Particulate Emissions

R= Rated capacity of incinerator (150 lbs/hr)

Emissions Limitation:

NOx emissions from this emission unit shall not exceed 0.23 lbs/hr and 0.99 tons per year.

Applicable Compliance Method:

The short term emissions (pounds per hour) shall be determined by the following equation:

$$E \text{ (lb/hr)} = EF * R$$

$$E \text{ (tons/year)} = PE \text{ (lb/hr)} * 8760 \text{ hr/year} * 1/2000 \text{ lb/ton}$$

Where:

E= NOx Emissions

R= Rated capacity of incinerator (150 lb/hr)

EF= Emission factor taken from AP-42 Table 2.1-12, October 1996 (3 lb/ton)

Emissions Limitation:

CO emissions from this emission unit shall not exceed 0.75 lbs/hr and 3.29 tons per year.

Applicable Compliance Method:

The short term emissions (pounds per hour) shall be determined by the following equation:

$$E \text{ (lb/hr)} = EF * R$$

$$E \text{ (tons/year)} = PE \text{ (lb/hr)} * 8760 \text{ hr/year} * 1/2000 \text{ lb/ton}$$

Where:

E= CO Emissions

R= Rated capacity of incinerator (150 lb/hr)

EF= Emission factor taken from AP-42 Table 2.1-12, October 1996 (10 lb/ton)

Visible emissions shall not exceed five (5) percent opacity as a six-minute (6) minute average except for six minutes (6) during any sixty (60) minute period during which the opacity shall not exceed ten (10) percent.

Applicable Compliance Method:

USEPA Method 9, (40 CFR Part 60, Appendix A).

Emissions Limitation:

Particulate Emissions: 0.10 pounds per 100 pounds of material charged.

Applicable Compliance Method:

If required, compliance with this mass emission limitation shall be based on stack testing per OAC rule 3745-17-03(B)(8) (Methods 1-5, 40 CFR Part 60, Appendix A).
