Part I - GENERAL TERMS AND CONDITIONS

A. Permit to Install General Terms and Conditions

1. Compliance Requirements

The emissions unit(s) identified in this Permit to Install shall remain in full compliance with all applicable State laws and regulations and the terms and conditions of this permit.

2. Reporting Requirements

The permittee shall submit required reports in the following manner:

- a. Reports of any required monitoring and/or recordkeeping information shall be submitted to the appropriate Ohio EPA District Office or local air agency.
- b. Except as otherwise may be provided in the terms and conditions for a specific emissions unit, quarterly written reports of (a) any deviations (excursions) from emission limitations, operational restrictions, and control device operating parameter limitations that have been detected by the testing, monitoring, and recordkeeping requirements specified in this permit, (b) the probable cause of such deviations, and (c) any corrective actions or preventive measures which have been or will be taken, shall be submitted to the appropriate Ohio EPA District Office or local air agency. If no deviations occurred during a calendar quarter, the permittee shall submit a quarterly report, which states that no deviations occurred during that quarter. The reports shall be submitted quarterly, i.e., by January 31, April 30, July 31, and October 31 of each year and shall cover the previous calendar quarters. (These quarterly reports shall exclude deviations resulting from malfunctions reported in accordance with OAC rule 3745-15-06.)

3. Records Retention Requirements

Each record of any monitoring data, testing data, and support information required pursuant to this permit shall be retained for a period of five years from the date the record was created. Support information shall include, but not be limited to, all calibration and maintenance records and all original strip-chart recordings for continuous monitoring instrumentation, and copies of all reports required by this permit. Such records may be maintained in computerized form.

4. Inspections and Information Requests

The Director of the Ohio EPA, or an authorized representative of the Director, may, subject to the safety requirements of the permittee and without undue delay, enter upon

the premises of this source at any reasonable time for purposes of making inspections, conducting tests, examining records or reports pertaining to any emission of air contaminants, and determining compliance with any applicable State air pollution laws and regulations and the terms and conditions of this permit. The permittee shall furnish to the Director of the Ohio EPA, or an authorized representative of the Director, upon receipt of a written request and within a reasonable time, any information that may be requested to determine whether cause exists for modifying, reopening or revoking this permit or to determine compliance with this permit. Upon verbal or written request, the permittee shall also furnish to the Director of the Ohio EPA, or an authorized representative of the Director, copies of records required to be kept by this permit.

5. Scheduled Maintenance/Malfunction Reporting

Any scheduled maintenance of air pollution control equipment shall be performed in accordance with paragraph (A) of OAC rule 3745-15-06. The malfunction of any emissions units or any associated air pollution control system(s) shall be reported to the appropriate Ohio EPA District Office or local air agency in accordance with paragraph (B) of OAC rule 3745-15-06. Except as provided in that rule, any scheduled maintenance or malfunction necessitating the shutdown or bypassing of any air pollution control system(s) shall be accompanied by the shutdown of the emissions unit(s) that is (are) served by such control system(s).

6. Permit Transfers

Any transferee of this permit shall assume the responsibilities of the prior permit holder. The appropriate Ohio EPA District Office or local air agency must be notified in writing of any transfer of this permit.

7. Air Pollution Nuisance

The air contaminants emitted by the emissions units covered by this permit shall not cause a public nuisance, in violation of OAC rule 3745-15-07.

8. Termination of Permit to Install

This Permit to Install shall terminate within eighteen months of the effective date of the Permit to Install if the owner or operator has not undertaken a continuing program of installation or modification or has not entered into a binding contractual obligation to undertake and complete within a reasonable time a continuing program of installation or modification. This deadline may be extended by up to 12 months if application is made to the Director within a reasonable time before the termination date and the party shows good cause for any such extension.

9. Construction of New Sources(s)

The proposed emissions unit(s) shall be constructed in strict accordance with the plans and application submitted for this permit to the Director of the Ohio Environmental Protection Agency. There may be no deviation from the approved plans without the express, written approval of the Agency. Any deviations from the approved plans or the above conditions may lead to such sanctions and penalties as provided under Ohio law. Approval of these plans does not constitute an assurance that the proposed facilities will operate in compliance with all Ohio laws and regulations. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed sources cannot meet the requirements of this permit or cannot meet applicable standards.

If the construction of the proposed emissions unit(s) has already begun or has been completed prior to the date the Director of the Environmental Protection Agency approves the permit application and plans, the approval does not constitute expressed or implied assurance that the proposed facility has been constructed in accordance with the approved plans. The action of beginning and/or completing construction prior to obtaining the Director's approval constitutes a violation of OAC rule 3745-31-02. Furthermore, issuance of the Permit to Install does not constitute an assurance that the proposed source will operate in compliance with all Ohio laws and regulations. Approval of the plans in any case is not to be construed as an approval of the facility as constructed and/or completed. Moreover, issuance of the Permit to Install is not to be construed as a waiver of any rights that the Ohio Environmental Protection Agency (or other persons) may have against the applicant for starting construction prior to the effective date of the permit. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed facilities cannot meet the requirements of this permit or cannot meet applicable standards.

10. Public Disclosure

The facility is hereby notified that this permit, and all agency records concerning the operation of this permitted source, are subject to public disclosure in accordance with OAC rule 3745-49-03.

11. Applicability

This Permit To Install is applicable only to the emissions unit(s) identified in the Permit To Install. Separate Permit To Install for the installation or modification of any other emissions unit(s) are required for any emissions unit for which a Permit To Install is required.

12. Best Available Technology

As specified in OAC Rule 3745-31-05, all new sources must employ Best Available Technology (BAT). Compliance with the terms and conditions of this permit will fulfill this requirement.

13. Source Operation and Operating Permit Requirements After Completion of Construction

This facility is permitted to operate each source described by this Permit to Install for a period of up to one year from the date the source commenced operation. This permission to operate is granted only if the facility complies with all requirements contained in this permit and all applicable air pollution laws, regulations, and policies. Pursuant to OAC Chapter 3745-35, the permittee shall submit a complete operating permit application within ninety (90) days after commencing operation of the emissions unit(s) covered by this permit.

14. Construction Compliance Certification

The applicant shall provide Ohio EPA with a written certification (see enclosed form) that the facility has been constructed in accordance with the Permit to Install application and the terms and conditions of the Permit to Install. The certification shall be provided to Ohio EPA upon completion of construction but prior to startup of the source.

15. Fees

The permittee shall pay fees to the Director of the Ohio EPA in accordance with ORC section 3745.11 and OAC Chapter 3745-78. The permittee shall pay all applicable Permit to Install fees within 30 days after the issuance of this Permit to Install.

A. Applicable Emissions Limitations and/or Control Requirements

Emissions from this unit shall not exceed the listed limitations, and the listed control measures shall be specified in narrative form following the table.

2. Additional Terms and Conditions

- 2.a The "Best Available Technology" (BAT) control requirement for emission unit N001 has been determined to be the use of an afterburner.

BAT requirements also include compliance the terms and conditions of this permit.

- 2.b Visible particulate emissions from emissions unit N001 shall not exceed 5% opacity except for 6 minutes in any continuous 60 minute period during which the opacity shall not exceed 10%.

- 2.c The visible particulate emission limitation specified by this rule is less stringent than the emission limitation established by OAC rule 3745-31-05 (A)(3).

- 2.d The emission limitation specified by this rule is less stringent than the emission limitation established by OAC rule 3745-31-05 (A)(3).
- 2.e The animal cremation multiple chamber incinerator, including all associated equipment and grounds, shall be designed, operated and maintained so as to prevent the emission of objectionable odors.
- 2.f The animal cremation multiple chamber incinerator, including all associated equipment and grounds, shall be designed, operated and maintained in accordance with the manufacturer's recommendations, instructions, and operating manual(s).

B. Operational Restrictions

1. The animal cremation multiple chamber incinerator shall be installed, operated, and maintained in accordance with the manufacturer's specifications. The secondary combustion chamber shall be designed to have a residence time of not less than one second at a minimum of 1600 degrees Fahrenheit, as measured by the secondary chamber indicator, before ignition of the burner to start the cremation.
 - a. during startup-the temperature controller for the secondary chamber shall be set at a minimum of 1600 degrees Fahrenheit; and
 - b. for the first cremation of the day, or for a subsequent cremation after the unit has entered or completed the cool-down state, the temperature must reach a minimum of 1600 degrees Fahrenheit, as measured by the secondary chamber indicator, before ignition of the burner to start the cremation.
2. The incinerator shall not be operated unless the temperature monitoring devices are operating properly.
3. The permittee shall not charge the incinerator with "infectious waste" as defined in OAC rule 3745-75-01 (C) (5).

C. Monitoring and/or Record keeping Requirements

1. The permittee shall install, operate, and properly maintain a temperature gauge which monitors the temperature of the secondary combustion chamber.

2. The permittee shall record and maintain daily records of the temperature of the secondary chamber, recorded just prior to main burner ignition
3. The permittee shall maintain daily records of the following information for emissions unit N001:
 - a. for batch feed operations:
 - i. for each cremation, the temperature of the secondary chamber must be recorded just prior to main burner ignition;
 - ii. the weight of each charge; and
 - iii. the time of each charge.
 - b. For continuous or intermittent feed operations, a scale shall be installed near this incinerator to weigh all of the material charged to the unit. A log shall be kept to record the amount of material charged to this unit on a pounds per hour basis. Alternative arrangements may be approved by the Director provided they can be shown to be of equivalent effectiveness as a method of regulating flow into the incinerator and generating a permanent record of charging rates.

D. Reporting Requirements

1. In accordance with the general terms and conditions of this permit, the permittee shall submit deviation (excursion) reports which provide the following information:
 - a. for each period during which the secondary combustion chamber exhaust gas temperatures fall below the applicable limitations:
 - i. the date of the excursion;
 - ii. the time interval which the excursion occurred; and
 - iii. the temperature values during the excursion.
 - b. an identification of all hours of operation during which the charge rate exceeded the incinerator's design capacity including the actual charge rates for such hours of operation.

E. Testing Requirements

1. Compliance with the emission limitations specified in section A.1. of this permit shall be determined in accordance with the following methods:

- a. **Emission Limitation:**
0.10 lb PE/hr and 0.44 ton PE/yr

Applicable Compliance Method:

The emission limitation was established in accordance with stack test data for an identical unit, performed on January 24, 2002. If required, the permittee shall demonstrate compliance by testing in accordance with Methods 1-5 of CFR Part 60, Appendix A.

The annual PE emission limitation was developed by multiplying the lb/hr limitation by a maximum operating schedule of 8760 hr/yr, and dividing by 2000 lbs/ton. Therefore, provided compliance is shown with the hourly limitation, compliance will also be shown with the annual limitation.

- b. **Emission Limitation:**
Visible particulate emissions shall not exceed 5% opacity except for 6 minutes in any continuous 60 minute period during which opacity shall not exceed 10%.

Applicable Compliance Method:

If required, the permittee shall demonstrate compliance with this emission limitation in accordance with Method 9 of 40 CFR Part 60, Appendix A.
