The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section. Substantial construction for installation must take place within eighteen months of the effective date of this permit. This deadline may be extended by up to twelve months, if application is made to the Director no less than sixty days before the expiration of this permit and the party shows good cause for any such extension.

The Director of the Ohio Environmental Protection Agency, or his authorized representatives, may enter upon the premises of the above named applicant during construction and operation at any reasonable time for the purpose of making inspections, conducting tests, examining records or reports pertaining to the construction, modification or installation of the above described source of environmental pollutants.

If the construction of the proposed source has already begun or has been completed prior to the date the director of the Ohio Environmental Protection agency approves the permit application and plans, the approval does not constitute expressed or implied assurance that the proposed facility has been constructed in accordance with the approved plans. The action of beginning and/or completing construction prior to obtaining the Director's approval constitutes a violation of OAC rule 3745-31-02. Furthermore, issuance of the Permit to Install does not constitute an assurance that the proposed source will operate in compliance with all Ohio laws and regulations. Approval of the plans in any case is not to be construed as an approval of the facility as constructed and/or completed. Moreover, issuance of the Permit to Install is not to be construed as a waiver of any rights that the Ohio Environmental Protection Agency (or other persons) may have against the applicant for starting construction prior to the effective date of the permit. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed facilities prove to be inadequate or cannot meet applicable standards.

The specified permit fee must be remitted within 30 days of the effective date of this Permit to Install Modification.

This permit shall apply only to the source(s) identified below based on the application received by the Ohio Environmental Protection Agency.

This permit applies only to the installation or modification of a source of air pollutants, and does not grant approval for installing or modifying a new source (wastewater) treatment works or solid waste disposal facility.

Before a Permit to Operate can be issued, a Permit to Operate Application must be submitted to the Northwest District Office of the Ohio EPA for each individual air contaminant source covered by this Permit to Install.

Emission Unit B301 - Konus Oil Heater

The emission rate of particulate matter shall not exceed 0.40 pounds per million BTU's of actual heat input.

The use of flyash reinjection is prohibited.
