You are hereby notified that the Ohio Environmental Protection Agency has made a draft action recommending that the Director issue a Permit to Install modification for the air contaminant source(s) [emissions unit(s)] shown on the enclosed draft permit modification. This draft action is not an authorization to begin construction or modification of your emissions unit(s). The purpose of this draft is to solicit public comments on the proposed installation. A public notice concerning the draft permit will appear in the Ohio EPA Weekly Review and the newspaper in the county where the facility will be located. Public comments will be accepted by the field office within 30 days of the date of publication in the newspaper. Any comments you have on the draft permit modification should be directed to the appropriate field office within the comment period. A copy of your comments should also be mailed to Robert Hodanbosi, Division of Air Pollution Control, Ohio EPA, P.O. Box 1049, Columbus, OH, 43266-0149.

A Permit to Install modification may be issued in proposed or final form based on the draft action, any written public comments received within 30 days of the public notice, or record of a public meeting if one is held. You will be notified in writing of a scheduled public meeting. Upon issuance of a final Permit to Install modification a fee of \$ 200 will be due. Please do not submit any payment now.

GENERAL PERMIT CONDITIONS

TERMINATION OF PERMIT TO INSTALL

Substantial construction for installation must take place within 18 months of the effective date of this permit. This deadline may be extended by up to 12 months if application is made to the Director within a reasonable time before the termination date and the party shows good cause for any such extension.

NOTICE OF INSPECTION

The Director of the Ohio Environmental Protection Agency, or his authorized representatives, may enter upon the premises of the above-named applicant during construction and operation at any reasonable time for the purpose of making inspections, conducting tests, or to examine records or reports pertaining to the construction, modification or installation of the source(s) of environmental pollutants identified within this permit.

CONSTRUCTION OF NEW SOURCES

The proposed source(s) shall be constructed in strict accordance with the plans and application submitted for this permit to the Director of the Ohio Environmental Protection Agency. There may be no deviation from the approved plans without the express, written approval of the Agency. Any deviations from the approved plans or the above conditions may lead to such sanctions and penalties as provided under Ohio law. Approval of these plans does not constitute an assurance that the proposed facilities will operate in compliance with all Ohio laws and regulations. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed sources are inadequate or cannot meet applicable standards.

If the construction of the proposed source(s) has already begun or has been completed prior to the date the Director of the Environmental Protection Agency approves the permit application and plans, the approval does not constitute expressed or implied assurance that the proposed facility has been constructed in accordance with the approved plans. The action of beginning and/or completing construction prior to obtaining the Director's approval constitutes a violation of Ohio Administrative Code (OAC) Rule 3745-31-02. Furthermore, issuance of the Permit to Install does not constitute an assurance that the proposed source will operate in compliance with all Ohio laws and regulations. Approval of the plans in any case is not to be construed as an approval of the facility as constructed and/or completed. Moreover, issuance of the Permit to Install is not to be construed as a waiver of any rights that the Ohio Environmental Protection Agency (or other persons) may have against the applicant for starting construction prior to the effective date of the permit. Additional facilities shall be installed upon orders of the Ohio Environmental Protection Agency if the proposed facilities cannot meet applicable standards.

PERMIT TO INSTALL FEE

In accordance with Ohio Revised Code 3745.11, the specified Permit to Install fee must be remitted within 30 days of the effective date of this permit to install.

PUBLIC DISCLOSURE

The facility is hereby notified that this permit, and all agency records concerning the operation of this permitted source, are subject to public disclosure in accordance with OAC Rule 3745-49-03.

APPLICABILITY

This Permit to Install is applicable only to the contaminant sources identified. Separate application must be made to the Director for the installation or modification of any other contaminant sources.

BEST AVAILABLE TECHNOLOGY

As specified in OAC Rule 3745-31-05, all new sources must employ Best Available Technology (BAT). Compliance with the terms and conditions of this permit will fulfill this requirement.

PERMIT TO OPERATE APPLICATION AND OPERATION AFTER COMPLETION OF CONSTRUCTION

If the permittee is required to apply for a Title V permit pursuant to OAC Chapter 3745-77, the permittee shall submit a complete Title V permit application or a complete Title V permit modification application within twelve (12) months after commencing operation of the emissions units covered by this permit. However, if the proposed new or modified source(s) would be prohibited by the terms and conditions of an existing Title V permit, a Title V permit modification must be obtained before the operation of such new or modified source(s) pursuant to OAC rule 3745-77-04(D) and OAC rule 3745-77-08(C)(3)(d).

If the permittee is required to apply for permit(s) pursuant to OAC Chapter 3745-35, the source(s) identified in this Permit To Install is (are) permitted to operate for a period of up to one year from the date the source(s) commenced operation. Permission to operate is granted only if the facility complies with all requirements contained in this permit and all applicable air pollution laws, regulations, and policies. Pursuant to OAC Chapter 3745-35, the permittee shall submit a complete operating permit application within ninety (90) days after commencing operation of the source(s) covered by this permit.

SOURCE OPERATION AFTER COMPLETION OF CONSTRUCTION

This facility is permitted to operate each source described by this permit to install for a period of up to one year from the date the source commenced operation. This permission to operate is granted only if the facility complies with all requirements contained in this permit and all applicable air pollution laws and regulations.

The owner/operator shall comply with any applicable state and federal requirements governing the storage, treatment, transport and disposal of any waste material generated by the operation of the sources.

MAINTENANCE OF EQUIPMENT

This source and its associated air pollution control system(s) shall be maintained regularly in accordance with good engineering practices and the recommendations of the respective manufacturers in order to minimize air contaminant emissions.

AIR POLLUTION NUISANCES PROHIBITED

The air contaminant source(s) identified in this permit may not cause a public nuisance in violation of OAC Rule 3745-15-07.

ADDITIONAL SPECIAL TERMS AND CONDITIONS

1. Coating usage in paint spray booth #2 (K002) shall not exceed 10 gallons per day. The OC content of coatings employed shall not exceed 7.15 lbs OC per gallon of coating as applied. This source has been modified from a OC content of 5.94 pounds per gallon.
2. Coating usage in paint spray booth #1 (K003) shall not exceed 10 gallons per day. The OC content of coatings employed shall not exceed 5.70 lbs OC per gallon of coating as applied. This source has been modified from a OC content of 4.99pounds per gallon.
3. The net OC emission increase from this modification is equal to 3.47 TPY.
4. The permittee has requested federally enforceable limitations of 9.9 tons of any individual Hazardous Air Pollutant (HAP), as defined in Section 112(b) of the Clean Air Act, and 24.9 tons of combined HAPs per

rolling, 12-month period for emissions units K001, K002, K003, K004, K005, K006, K008, K009, K010, K011, and K012, combined, for the purposes of avoiding the requirements of 40 CFR Part 63, Subpart MMMM (Emissions units K005 and K006 were originally permitted as emissions units K002 and K003, respectively, in PTI #03-05558. Emissions units K009 and K012 were originally permitted as emissions units K001 and K004, respectively, in PTI #03-05560. Emissions units K010 and K011 were originally permitted as emissions units K002 and K003, respectively, in PTI #03-08604.)

To ensure federal enforceability during the first 12 calendar months of operation, the permittee shall not exceed the HAP emission rates specified in the following table:

After the first 12 calendar months of operation, compliance with the annual HAP emission limitations shall be based upon a rolling, 12-month summation of the monthly HAP emission rates for emissions units K001, K002, K003, K004, K005, K006, K008, K009, K010, K011, and K012, combined.

5. The company shall maintain daily records which list the following information for coatings employed in sources K002 and K003:
 - A. company I.D. of the coating;
 - B. the number of gallons of each coating employed per day;
 - C. the VOC content of each coating in lbs/gallon "as applied"; and

D. the amount of VOC emitted (lbs/day and tons/year).

For any exceedance of the emission limitations and or coating restrictions of this permit, Alpha Coatings, Inc. shall notify the Ohio Environmental Protection Agency (OEPA), Northwest District Office, Division of Air Pollution Control within forty-five (45) days.

These records shall be maintained on company file for a period of no less than three years and be made available to the Director or any authorized representative of the Director for review during normal business hours.

6. In order to demonstrate compliance with the rolling, 12-month HAP emission limitations, the permittee shall collect and record the following information for emissions units K001, K002, K003, K004, K005, K006, K008, K009, K010, K011, and K012, combined:
- A. the company identification of each coating employed;
 - B. the pounds per gallon of each HAP in each coating, as applied;
 - C. the number of gallons of each coating employed;
 - D. the emission rate, in pounds, for each HAP from each coating employed [(b) x (c)];
 - E. the total emission rate for each HAP from all coatings employed [summation of (d) for each HAP], in pounds per month;
 - F. the total HAP emission rate for the combination of all HAPs from all coatings employed [summation of (e)], in pounds per month;
 - G. for the first 12 months of operation following the issuance of this permit, the cumulative monthly emission rate of each individual HAP and the combination of all HAPs, in tons per month, and
 - H. after the first 12 months of operation under the provisions of this permit, the annual emissions of each HAP and the combination of all HAPs, based upon a rolling 12-month summation.

Note: The coating information recorded above must be for the materials as employed, including any thinning solvents added at the emissions unit.

7. The permittee shall submit quarterly reports documenting any exceedance of the emission limitations/coating restrictions for sources K002 and K003 to the Ohio EPA district office. For each exceedance, the permittee shall also provide the following additional information:

8. The permittee shall submit quarterly deviation (excursion) reports for emissions units K001, K002, K003, K004, K005, K006, K008, K009, K010, K011, and K012, combined, as follows:
 - A. For the first 12 calendar months of operation, the permittee shall submit deviation (excursion) reports, which identify any exceedances of the maximum allowable cumulative HAP emission levels specified in Additional Special Terms and Conditions #4.
 - B. After the first 12 calendar months of operation, the permittee shall submit deviation (excursion) reports, which identify any exceedances of the rolling, 12-month HAP emission limitations.

If no deviations occurred during a calendar quarter, the permittee shall submit a quarterly report, which states that no deviations occurred during that quarter. The reports shall be submitted quarterly, i.e., by January 31, April 30, July 31, and October 31 of each year and shall cover the previous calendar quarters.

9. All reports are to be submitted to the Ohio EPA, Northwest District Office, 347 North Dunbridge Road, Bowling Green, Ohio 43402.

Synthetic Minor Determination

A. Source Description

Alpha Coatings, Inc - Port Clinton Plant involves eight coating operations for metal and non-metal parts.

B. Facility Emissions and Attainment Status

The issuance of this proposed permit will establish Alpha Coatings, Inc. as a minor stationary source for Maximum Achievable Control Technology (MACT) applicability by the establishment of synthetic minor limitation on HAPs. American Trim, L.L.C. is located in Ottawa County which is in attainment for all criteria pollutants

C. Source Emissions

The proposed permit will also establish the following HAP limitations:

9.9 tons/rolling 12-month period for any individual HAP from all coating operations (emissions unit K002, K003, K004, K005, R002, & R003 combined)

24.9 tons/rolling 12-month period for any combination of HAPs from all coating operations (emissions unit K002, K003, K004, K005, R002, & R003 combined)
