This version of facility specific terms and conditions was converted from a database format to an HTML file during an upgrade of the Ohio EPA, Division of Air Pollution Control's permitting software. Every attempt has been made to convert the terms and conditions to look and substantively conform to the permit issued or being drafted in STARS. However, the format of the terms may vary slightly from the original. In addition, although it is not expected, there is a slight possibility that a term and condition may have been inadvertently "left out" of this reproduction during the conversion process. Therefore, if this version is to be used as a starting point in drafting a new version of a permit, it is imperative that the entire set of terms and conditions be reviewed to ensure they substantively mimic the issued permit. Part II - Special Terms and Conditions

This permit document constitutes a permit-to-install issued in accordance with ORC 3704.03(F) and a permit-to-operate issued in accordance with ORC 3704.03(G).

B. Operational Restrictions

1. The pressure drop across the baghouse shall be maintained within the range of 3-8 inches of water while the emissions unit is in operation.

C. Monitoring and/or Record Keeping Requirements

1. The permittee shall properly install, operate, and maintain equipment to monitor the pressure drop across the baghouse while the emissions unit is in operation. The monitoring equipment shall be installed, calibrated, operated, and maintained in accordance with the manufacturer's recommendations, instructions, and operating manual(s). The permittee shall record the pressure drop across the baghouse on a daily basis.

D. Reporting Requirements

1. The permittee shall submit pressure drop deviation (excursion) reports that identify that all periods of time during which the pressure drop across the baghouse did not comply with the allowable range specified above.

E. Testing Requirements

1. Emission Limitation:
Emissions of particulate matter (PM) shall not exceed 0.030 gr/dscf.

Compliance Method:
If required, the following test method(s) shall be employed to demonstrate compliance with the allowable mass emission rate(s): Methods 1-4 and Method 5. Alternative U.S. EPA approved test methods may be used with prior approval from the Ohio EPA.
2. Emissions Limitation:
Visible particulate emissions shall not exceed 20% opacity from the stack, except as specified by rule.

Compliance Method:
If required, compliance with the 20% opacity limit shall be determined in accordance with USEPA Method 9.
