NOTICE OF RECEIPT OF 401 APPLICATION**

Public notice is hereby given that the Ohio Environmental Protection Agency (Ohio EPA) Division of Surface Water (DSW) has received an application for, and has begun to consider whether to issue or deny, a Clean Water Act Section 401 water quality certification for a project to construct a power substation and associated access road on an approximately 11 acre site. The application was submitted by The Ohio State University. The project site is located near the northwest corner of the intersection of Kenny Road and Kinnear Road on The Ohio State University Campus in Clinton Township, Franklin County, Ohio. The Huntington District Corps of Engineers Public Notice Number for this project is LRH-2009-726-OLR. The Ohio EPA ID Number for this project is 103614.

As required by the Antidegradation Rule, rule 3745-1-05 of the Ohio Administrative Code (OAC), three alternatives have been submitted for the project. The applicant's proposed preferred alternative, if approved, would impact 720 linear feet of low quality intermittent stream. The applicant's proposed minimal degradation alternative, if approved, would impact 595 linear feet of low quality intermittent stream. The applicant's proposed non-degradation alternative, if approved, would have no direct impacts on waters of the state.

Discharges from the activity, if approved, would result in degradation to, or lowering of, the water quality of an unnamed tributary to the Olentangy River. Ohio EPA will review the application, and decide whether to grant or deny the application, in accordance with OAC Chapters 3745-1 and 3745-32. In accordance with OAC rule 3745-1-05, an antidegradation review of the application will be conducted before deciding whether to allow a lowering of water quality. All three proposed alternatives will be considered during the review process. No exclusions or waivers, as outlined by OAC rule 3745-1-05, apply or may be granted.
