NOTICE OF RECEIPT OF 401 APPLICATION**

Public notice is hereby given that the Ohio Environmental Protection Agency (Ohio EPA) Division of Surface Water (DSW) has received an application for, and has begun to consider whether to issue or deny, a Clean Water Act Section 401 water quality certification for a project to replace approximately 2,800 feet of 30-inch diameter natural gas pipeline. The application was submitted by The East Ohio Gas Company. The project is located in Independence, Ohio. The Buffalo District Corps of Engineers Public Notice Number for this project is 2014-01294. The Ohio EPA ID Number for this project is 154609.

As required by the Antidegradation Rule, 3745-1-05, of the Ohio Administrative Code (OAC), three alternatives have been submitted for the project. The applicant's proposed preferred alternative, if approved, would impact 0.929 acres of Category 1 and 2 wetlands, 17 linear feet of intermittent streams and 1 linear foot of an ephemeral stream. The applicant's proposed minimal degradation alternative, if approved, would impact 0.798 acres of Category 1 and 2 wetlands, 17 linear feet of intermittent streams and 1 linear foot of an ephemeral stream. The applicant's proposed non-degradation alternative, if approved, would have no direct impacts on waters of the state.

Discharges from the activity, if approved, would result in degradation to, or lowering of, the water quality in the Cuyahoga River watershed. Ohio EPA will review the application, and decide whether to grant or deny the application, in accordance with OAC Chapters 3745-1 and 3745-32. In accordance with OAC rule 3745-1-05, an antidegradation review of the application will be conducted before deciding whether to allow a lowering of water quality. All three proposed alternatives will be considered during the review process. No exclusions or waivers, as outlined by OAC rule 3745-1-05, apply or may be granted.

Public notice is hereby given that the Ohio Environmental Protection Agency (Ohio EPA) Division of Surface Water (DSW) has received an application for, and has begun to consider whether to issue or deny, a Clean Water Act Section 401 water quality certification for a project to improve the Fosters-Maineville Road and Butterworth Road intersection. The application was submitted by the Warren County Engineer. The project is located at the intersection of Fosters-Maineville Road and Butterworth Road. The Huntington District Corps of Engineers Public Notice Number for this project is LRH-2013-934-LMR-UT Bear Run. The Ohio EPA ID Number for this project is 154608.

As required by the Anti-degradation Rule, 3745-1-05, of the Ohio Administrative Code (OAC), three alternatives have been submitted for the project. The applicant's proposed preferred alternative, if approved, would impact 200 linear feet of intermittent stream, and 596 linear feet of ephemeral stream. The applicant's proposed minimal degradation alternative, if approved, would 106 linear feet of intermittent stream, and 116 linear feet of ephemeral stream. The applicant's proposed non-degradation alternative, if approved, would have no direct impacts on waters of the state.

Discharges from the activity, if approved, would result in degradation to, or lowering of, the water quality of Little Miami River. Ohio EPA will review the application, and decide whether to grant or deny the application, in accordance with OAC Chapters 3745-1 and 3745-32. In accordance with OAC rule 3745-1-05, an anti-degradation review of the application will be conducted before deciding whether to allow a lowering of water quality. All three proposed alternatives will be considered during the review process. No exclusions or waivers, as outlined by OAC rule 3745-1-05, apply or may be granted.
